### Minutes 20th September 2021

- 1. Virtual meeting held on ZOOM. Present: Peter Hume, Christine Hadaway, Graham Woof, Beryl Lowry, Jorgen Boettiger, Lynne Rainford and Felicity Fane
- 2. Meeting declared open at 4:05pm
- 3. Apologies: Ann Snow
- 4. Conflicts of Interest nil stated.
- 5. Minutes of last meeting (30<sup>th</sup> August 2021): moved by Lynne R, seconded by Christine H and approved by President as true record to be recorded in Minute Book.
- 6. Business arising from August meeting:
  - Draft Complaint procedure:
    - Finalisation of draft for new complaint procedure awaiting the meeting of sub-committee. Date to be advised but has been delayed due to Covid lockdown.
    - George B has approached the late Pam Gowthorp's husband for any records in relation to her position as Recorder without success. George B has recovered Pam's keys for the club rooms and are in his possession and duly recorded in the Key Register.
    - ➤ Peter H had approached Jurate L as possible replacement Recorder. She has since declined
  - Christine H held a virtual Director's Meeting on Wednesday 15<sup>th</sup> September @4:00pm by ZOOM (see below)
  - Graham W sent out copies of September newsletter by (snail) mail to eight members with no email access, to alert them of the new Covid security policy for the return of face-to-face bridge
  - The apparent need for more time in the Club room for getting work done out of session by Christine H, Graham W and others, raised the safety issue of members (particularly the females) being in the Club room and the centre generally in nondaylight hours. Discussion deferred to a later date

#### 11. General Business:

- AGM for 2021:
  - ➤ As previously agreed, the AGM for 2021 will be held on Monday 22<sup>nd</sup> November 2021 @ 11:00am in the club rooms.
  - ➤ Date for AGM to be released in the October newsletter, along with requests for nominations and general business requests
- Return to face-to-face bridge in club rooms (including matters discussed in Director's Report above):
  - ➤ Committee has agreed that from now on all participants in face-to-face bridge at BWBC will be required to have been fully vaccinated (two jabs) against Covid-19
  - Additionally, all participants will be required to produce official Australian Government Covid-19 digital certificate (dated ten days prior) before entering Club rooms
  - ➤ A Vaccination Register has been drawn up by Graham W (eg., Appendix)
  - A table to be set up outside the club room prior to each session and manned by two persons.
  - ➤ One person will take the session fee and check the temperature of attendees
  - The second person will check each attendee's vaccination certificate, marking down on the register the date of their 2<sup>nd</sup> jab and signing their name as having viewed the certificate
  - At the completion of the session the register, in a plastic folder, will be kept in the club room to be used for succeeding sessions going forward
  - ➤ Mask will be compulsory, and attendees will be reminded to also use the QR code
  - ➤ Graham W has volunteered to attend each session for the first week of reopening to operate the Vaccination Register as the 2<sup>nd</sup> person
  - Christine H will prepare a roster for nominating persons to fill the two roles for each session
  - ➤ Attendees to be requested to show up from 20 minutes in advance of start time to allow more processing time
  - Sylvia F to provide additional hand sanitiser
- Christine H suggested a likely start date of Monday 11 October for return to face-to-face bridge
- Peter H to schedule 'Octoberfest' Red point sessions for the 2<sup>nd</sup> week back
- Peter H to also schedule Novice Pairs Championship event for soon after the return
- 12. Next meeting proposed for Monday 18<sup>th</sup> October at 10:30am in the club rooms.
- 13. Meeting closed at approximately 5:20pm.
