- Chief Director's Report BWBC October 2022

The Oktoberfest Pairs went well. The German catering was much enjoyed. Thanks to the helpers. The Novice events were well attended and enjoyed also. There are several issues of concern around our restricted and novice sessions that I would like addressed by the committee. The first being the directing of the novice section on Mondays. An informal meeting took place on Wednesday morning 12 th Oct. amongst concerned parties. Players were upset by the way they were spoken to and continually told to hurry up and that they were too slow. After listening to all of their concerns I decided that in future they would only play 24 boards and be given at least 7.5 minutes per board. That is they have 23 minutes to play thee boards and 30 minutes to play four boards. Also the novice section would play in the 1st and 2<sup>nd</sup> rows in the main room and the timer would be set for them. This worked very well the next week and I directed this section for the 1st week. A new timer has been purchased for the open section to follow. I think this will make the running of Mondays smoother for the director. The meeting recommended that the Wednesday session should be a Restricted session 1e< 300 masterpoints. There was concern about players in the "Novice" events that players with > 100 points took the novices masterpoints away from them.
