Committee Meeting January, 2023

- Meeting Opened 10:30am
- Present: Sylvia Foster, Barry Foster, Jaan Oitmaa, Laurie Powell, Susan Ashley, Kerrie Robertson and Chris Hasemore. Christine Hadaway attended as a special guest.
- Apologies: Jim Routledge, Beryl Lowry
- Minutes of December Meeting: Moved CH Seconded LP
- Business Arising from the Minutes:
 - Table etiquette. Carried over from last meeting. JO pointed out the need for JR to be present as he was the original speaker on the topic. Moved to February meeting.
 - BWBC Super Congress. Peter Hume has agreed to convene the congress. Costings are currently being obtained from Ettalong Diggers and Everglades Country Club. There was some discussion about an online congress v Face to Face. It was decided Face to Face bridge was the preferred option.
- Voting Outside of Normal Meeting: Nil
- Cruise Ship Allocation of BWBC Green Points:
 - At a previous meeting of the committee it was decided the club would not continue to allow Christine Hadaway to use the club MP system during her cruise ship bridge sessions. Christine attended today's meeting to address committee concerns about this unusual practice. It was pointed out that there are some positives for BWBC. Committee members asked a variety of questions and CH was able to allay their fears. It was decided to allow CH to continue to use the BWBC MP system during her cruise ship bridge sessions.

- Wednesday Afternoon Bridge:
 - $_{\odot}~$ It was decided to discuss this item now rather than in General Business.
 - SF proposed we run an open session on Wednesday afternoons concurrent with the <300MP session. However, due to lack of open players attending last week SF decided to mix the open and <300MP group together for one week only. It was clear the open session was not attracting suitable players and was only surviving due to club volunteers helping out. Although SF repeated on a number of occasions it was for one week only KR pointed out that some

<300MP players did not comprehend this fact and were upset that the session would now be open.

Although looking tenuous it was decided to keep the open trial going for a while longer.

 - $_{\odot}~$ It was decided to discuss this item now rather than in General Business.
 - SF pointed out that we do not have a formal web reporter. Web reports were done by Barry and Peter H as volunteers but it was not their job. They would make a report if time permitted but there were no guarantees. In addition, they are not present for all special events and find it difficult to report on something they don't know about.
 - LP volunteered to join the web master team. Laurie would be given training by Barry and Peter and would be first to make reports and web items.
 - If no member of the web team attended an event the Director should ask for a volunteer to write the report.

Beryl Lowry Letter to Committee

Thanks Barry for the minutes. I have sent my apologies but have a couple of

questions - may b they could be agenda items? Not sure.

One is re the Web-site event reports & the other re the Wed afternoon session. One question...who, if anyone, is responsible for writing up reports on the Special events & posting on the web-site? A notable omission recently was that of the biggest event of the year, the Christmas Party, which hosted comps over 3 MP sections. The report on the Melbourne Cup prevailed as did sliding photos of the 2021 Christmas Party. The Remembrance Day Red point day was also missed. The Report on the New Year's Cup comp reports the Novice section as being U25 pts whereas several players are over 25pts but U50, which is the regular Mon avo session criteria.

Re Wed avo session. I admire & appreciate Laurie's efforts to get another session running for Open players. However, it has been stressed to me by other players (& my thoughts too) that there are already 5 sessions per week for Open players. For the Wed afternoon Open session to prevail the web-site clearly says that a min of 3 tables is required but play occurred with less than 2 tables. OK, scores weren't posted & so obviously points didn't count, so why?? Three members who played Open qualify to play in the Restricted session anyway, including one novice U50. Myself & other players don't want to see this session interfere with attendance at the regular (Restricted) session. It has taken a while for beginners/rookies to play regularly in this session & we need to encourage them to continue, not drop out. They are the future of an ageing club.

At Jindabyne for a break, so enough from me, Regards, Beryl.

In answer to your questions. No one is responsible for writing up reports for the web site. Peter and Barry sometimes put up reports. With their heavy workload they are not able to cover everything. I for one am very appreciative of what they do and I don't think criticising their work is very productive when we have no one else at the moment.

Re Wednesday Afternoon

I made a last minute decision to run two table teams so we could get things going. The event was scored but Christine is waiting for Peter to show her how to put it on the net. The three restricted players who played had open players as partners which is why they played in the open. I can only count 4 sessions not 5 available to open players. Monday, Tuesday, Thursday and Saturday. I can't see anything wrong in trying to cater for all our players. Why should running an open session alongside a restricted session stop players from coming. We do this every Monday successfully. At the moment I have two tables of players willing to come each week. I think we should give it a month or so to see if it will work.

We can discuss all of this further at the meeting tomorrow. Regards Sylvia

disappointment in the committee's decision

I wish to express my disappointment in the committee's decision not to continue allowing me to award green points to sessions that I direct on cruise ships as a BWBC session. This is David Western's response to the inquiry: Hi Barrv. Don't remember ever coming across this sort of thing before. Previously anyone wishing to run holiday cruises and award masterpoints would need to register themselves as an ABF affiliated club via their State association. Once that was done, they would submit their holiday/cruise similarly to any other event (eg. Holiday/cruise/congress etc). It would be checked by me that the event was masterpointed in accordance with ABF policy and that all masterpoints for the event were awarded. If your club is going to be sponsoring(?) these holidays/cruises then both myself and the ABF will deal with your club, not Christine. The ABF will invoice your club for the masterpoints issued, and failure to pay will reflect badly on your club, not Christine. As far as the NSWBA and ABF would be concerned, the event is being run by your club, so all queries etc will be directed to your club. As long as your club is prepared to pay the invoices and respond to any emails regarding these events, then that is fine. It will be up to your club and Christine to sort out any re-imbursement of funds between the both of you. That would be of no interest to the NSWBA nor the ABF. I think it would be better, and safer, to just have Christine register a club via the NSWBA to run these cruises. Although if this is a once off event, then probably not warranted. Regards, DCW

I have run sessions away from our club before and I know of other clubs that have without

forming their own bridge club.

I made it very clear from the start that I would cover any expenses incurred to our club. I have already paid for the green points as calculated by our Masterpoint Secretary. Peter has no issues with my running the sessions as BWBC sessions as David points out: "That would be of no interest to the NSWBA nor the ABF."

It appears that David's only concern is about the payment of the masterpoints. I certainly will not be forming my own private bridge club just to run about two sessions a year and I assure you I will always cover any expenses to BWBC incurred by me. After all the work I have put into this club surely my word is good enough.

All of the green points from the cruise help our club accumulate red points, which you can see from last Monday's red point event are a great asset to our club. If I ran the sessions as my own private club I certainly would not run red point events and I could not transfer the green point to BWBC. They would be wasted.

I would be happy to attend today's meeting to answer any of your questions regarding this issue. I do hope you will reconsider your decision on this matter.

Masterpoints

Christine Hadaway ran sessions on a recent cruise and 14.61 green masterpoints awarded via BWBC. The MPts were in the December batch. Cost \$27.32 (\$1.87 per green MPt). Christine advised of cost and expected to reimburse club.

For information of the committee, here is the explanation of how the number of permitted red point events is calculated.

All clubs that are affiliated with the ABF at September 30th and have not less than 40 sessions scheduled during the following calendar year (as confirmed by an entry in the Affiliated Bridge Clubs Directory) are entitled to run 6 sessions of club red point events, masterpointed at grade B4c level, during that calendar year. Additional entitlements are as follows:

• One session for the first 35 green masterpoints issued by the club in the twelve months to September 30th of the preceding year.

• A further session for each additional 65 green masterpoints issued by the club in the twelve months to September 30th of the preceding year.
