

Results – Further Afield

♦ **Community (Bateau Bay) Bridge Club Interclub Teams (5th Sept.)**

A tough day's bridge, at The Entrance Leagues Club, with 14 teams from all the local clubs competing. Some Bridge Jargon

- ♦ a '**split deck**' means a deal with close to 20 points a side.
- ♦ a '**monster**' is a huge hand, in terms of high cards.
- ♦ '**double dummy**' means, literally, with two hands exposed. This means that each player can '**see**' all the cards.
- ♦ '**green**' and '**red**' mean not vulnerable and vulnerable, respectively.
- ♦ A '**goulash hand**' means a wild distribution. In the days of hand dealing, hands were sometimes dealt 5-3-5, which gave rise to some wild hands and wild bidding.
- ♦ a '**hook**' means a finesse.
- ♦ to '**build**' tricks means to establish extra tricks.
- ♦ a '**psyche**' is a crazy bid, made for tactical reasons to fool the opponents.
This is legal, as long as partner is also fooled, but not recommended.

Imagine the situation when declarer wins the trick in their hand but they call for a card from dummy first (that is they have led from the wrong hand). What do you do as a defender?


Fact 1 – there has been an infraction AND you have certain rights. Please call the Director to advise you. The problem is that this does not occur. Normally you just tell the declarer that they are playing from the wrong hand and so they correct it. You have done yourselves an injustice!!!

Fact 2 – Either defender MAY accept the lead from the wrong hand. The Director will give you both this option and will go with the first one of you to speak. If that was simultaneous, then they go with the person who was next to play after the irregular lead.

Refer to LAW 55 – Declarer's lead out of turn.

At the Bridge Table — By Jaan

Here is an interesting hand from our recent Novice Pairs Championship

(Session 1, board18) East dealer N/S vul.

Most East players would, I think, open 2 spades (or 2 diamonds, if playing multi-twos). South has two options – 3 clubs or double. I think double is better, but you need to have a tolerant partner, as you don't have diamond support you have promised. However, on this hand a 3 club overcall works out better. West, now, has a difficult choice. Do you raise to 4 spades immediately, or do you content yourself with 3 spades, hoping to play it there. There are two points of view. If South has bid 3 clubs previously, then, if you bid 4 spades

immediately, there is psychological pressure on North to bid 5 clubs as 'insurance'. If South has, instead, doubled then bidding 4 spades, immediately, seems better, as it may be difficult for North to continue. However, on this hand, North has an easy 5 diamond bid. Who said bidding is easy?

In practice, 5 E/W pairs were allowed to play in a spade contract and 1 N/S pair played in 5 clubs, making 11 tricks for a 'top'. In fact, 7 clubs and 7 diamonds are makeable if you see all hands, but that is fairyland stuff.
