### **Reports**

#### Treasurer.

There is a small surplus for this month. Table numbers are similar to last year but trending up.

### **Chief Director**

CH has stepped down from the Chief Director's job and Sylvia Foster has taken over the responsibility.

A Director's meeting has proposed a new schedule of fees. Very similar to the original version except that payment of Directors for Green Point sessions was increased from \$20 to \$45.

DB proposed the new schedule and SA accepted. (Five committee members accepted the new schedule of fees and two members abstained.)
